## 1. Introduction - Information Gathering and Use

## 3. Privacy of our email lists

Individuals who join our mailing lists via our website / through our campaigning engagements / participated in our event(s) are added to our email database. We do not sell, rent, loan, trade, or lease the addresses on our lists to anyone.

## 4. Security & Protection of Data

- Aaina uses well-recognised and proven technology for payments. Payment information is transferred by the use of an SSL connection which offers the highest degree of security that your browser is able to support.
- Several layers of built-in security, including an advanced firewall system, encryption of credit card numbers, and use of passwords, protect the collected information.

## 5. External Web Services

- We use a number of external web services on our site to display content within our web pages. For example, to display video we use YouTube. As with the social buttons, we cannot prevent these sites, or external domains, from collecting information on your use of the content we embed on our site.
