The vacation called off, people were requested to come back and the emergency operation was in place. 12th October the monster storm hit the Odisha coast with devastating force. Odisha Phailin Response Forum was formulated and Aaina became one of the lead organization coordinating the services and response. At the same time our Ganjam project was in dire need of attention due to the heavy storm effect. Immediate rescue and relief was in demand and Aaina jumped into the action keeping the experience of 1999 Super cyclone in mind. I take this opportunity to thank each

Aaina recognizes the rights of children and commits to facilitate their realization through appropriate participatory program interventions, leading to a non-discriminatory society.



Towards Ability and Inclusive Development Community based practices/programs

Towards inclusion project

Towards inclusion project of Aaina supported by PACS, DFID has completed successful two and a half years with the main objective of improving the livelihood alternatives for people with disability and women in 350 villages of Kandhamal and Boudh district. Also, it strives for inclusive education and education rights of children with disability. After several capacity building programmes, members of Shramik Sangha are demanding jobs on a regular basis and also asking for timely payment to their respective account. Moreover,

there is visible increase in knowledge of people related to child rights and various provisions in MGNREGA through IEC materials, leaflets and quiz competitions organised at regular intervals. Children are Advocating



for their education rights. The children clubs are discussing issues affecting their education with CPC and even addressing issues related to inclusion of CWDs in general school. Community members from this region participated in the state level Lok Sangathan Utsav organised by PACS on 14th and 15th March. There was a panel discussion on PWD leadership. Ms. Sneha Mishra, Secretary Aaina spoke on empowerment of people with disability.

Amo Vidyalaya

The integrated special school and sheltered workshop of people with disability have 43 members at Baranga. Besides the usual extension education support they produce various goods as a livelihood. They had supplied 500 Numbers of executive bag and had done a good business during BALI YATRA. Observation of festivals and national days is standard practice at the institution.

Empowerment of DPOs and SHG


The Satyabhama project running in Kamakhyanagar and Kankadahad block of Dhenkanal district is concentrating on community capacity building on service delivery and enhancing advocacy and economic independence of PWDs through DPO. One of the standing examples is of a DPO in Urbengi village of Kankadahada block. The DPO is headed by a woman. The group discovered the source of living from the nearby jungles. They are hand weaving foot-mats from a peculiar leave that grows in nearby forests. The mat sales at about Rs.100 each. The group makes Rs. 6000 to 7000 per month. The next step now is to tie up with government to assure a market for such groups. A talk to this effect with other DPOs of the area has already begun.

Trainings and capacity building Training on community participation in assistive devices making

A group of 20 staffs from Nav Bharat Jagriti Kendra, Jharkhand visited Aaina for an exposure visit to learn from the field operations in the CBR project in Kamakhyanagar. They came to know about the DPOs, the resource center managed by them and the pro-active involvement of other community members in the process of inclusion. The team then visited Kanpura village to



have a hands on training on assistive devices and adoptive devices. They have to either build devices or modify existing structures using material available around home or locally in consultation with parents or family members. Seven such devices or structural modifications were created by the team member in groups under the guidance of Mr. Pradyumna Kumar Rath, founder member of Aaina. Ms. Sneha Mishra, Secretary



Events and observations We care film fest III & international cerebral palsy day

Aaina conducted the 3rd annual We Care film festival of Bhubaneswar on 2nd and 3rd



October. The festival promotes inclusion and celebrates diversity through the medium of documentary films. October 2 was observed as World Cerebral Palsy Day for the first time in India. Aaina organized a rally to raise awareness among the

people on Cerebral Palsy. The rally was flagged off by Mr. Bibhuti Bhusana Pattnaik ,Director Disability & Mr. Sasank Padhi , State Programme Manager, Save the Children. Children and persons with Cerebral Palsy, their parents, teachers, media, NGO & INGO representatives, Govt. Officials joined the rally. Children & persons with cerebral palsy were felicitated for excellence. "One minute to Change my Life" - the documentary by Aaina was shown. A demonstration of software developed by TCS with accessibility features was given. A competitive Quiz Contest for the students and a live presentation by satirist Mr. Gyana Hota completed the Day. Screening of National Award Winning documentaries from the previous year, Screening of out of the box documentary "ACCSEX" by Ms. Shweta Ghosh, and screening of short documentaries in various competition category were the major activities of the 2nd day. A special section on one minute movies by children was introduced this year. A total of 27 entries were shown. Mr. Sarat Pujari as usual guest delivered an emotional and inspirational speech. Finally the results of the movies competition were announced and the lucky draw of the raffle tickets made.



Aaina observed the International Day for Persons with Disability on 3rd December at District Veterinary Training Hall, Phulbani. There was discussion on inclusion of person with disability in MGNREGA, and the type of work facility available under it. Ms. Sujata Mohapatra, Project Coordinator (Livelihood), Aaina shared inspirational case studies



The Chief Guest Ms. Manjula Pradhan spoke on care of women with disability during pregnancy and after the delivery, coping strategies for people with disability and access to joyful learning at ICDS centers by children with disability. Ms.Laxmi Das talked about the

attitudinal and financial barrier for persons with disability and further discussed on ways of efficiently running of SHG AQuiz Competition was conducted for participants as well. It was an entertaining and productive event for people with disabilities where they participated and learned about their rights.

Collaboration with RGF and VYK

Rajiv Gandhi Foundation collaborated with Aaina for distributing adapted scooters to young and active persons with disability to enhance their access reach and independence. 20 persons received scooters from RGF this year. Additionally a capacity building



trainings was organized for the PWDs from 11 districts to scale them as future leaders. Similarly, Viswa Yubak Kendra (VYK) collaborated with aaina to develop the entrepreneurship skill of the selected PWDs through trainings and machinery support and total 32 entrepreneurship have developed in 2 districts of Odisha.

Towards Gender Equality and Women Empowerment





Highlights

 More than 130 adolescent groups have been formed to spread awareness on Menstrual Hygiene under the aaina's project on Menstrual Hygiene in partnership with Water Aid

* Aaina has partnered with more than 100 school authorities across 70 villages to create awareness on Menstrual Hygiene and 61 sensitization meetings with women SHG,ASHA and ANM workers have been organised.

* 33 PRI members attended the training and assured equal participation of women at every level in a training organised by aaina on Empowerment of Women through capacity building of PRI members

 About 150 people in 50 bikes joined the rally on International Day to eliminate Violence against Women on November 25. **Towards Gender Equality and women empowerment** Community based practices/programs *Menstrual hygiene*



Acknowledging the dire need to break the culture of silence and discuss about the concerns of rural women related to reproductive and sexual health. Aaina with support of Water Aids takes a responsibility to improve health and well being of adolescent girls and women through better menstrual hygiene practices. In three blocks of Ganjam district covering 70 villages. The project aims to improve the knowledge base of the target population on the issue to have better menstrual hygiene management. It also considers the production and availability of low cost sanitary napkins to all target groups. For larger impact the project shall also sensitize policy makers to sanitation; create awareness on health and hygiene at the district, block and local level; constantly upgrade the knowledge and capacity of various stakeholders on MHM; remove the social stigma attached to menstruation.

Major activities include awareness and training session's sessions at community and block level on menstrual hygiene and safe disposal of sanitary napkins, meetings with Parent Teacher's Association and school management committees and formation of young group leaders to spread the knowledge, Aaina's work on this project was appreciated by Dasra Girl Power Awards as well and the organization was short listed amongst the top 5 NGOs across country working in the Health sector.

Trainings and capacity building Women empowerment through capacity building of PRI members

Aaina organized a capacity building training programme for PRI members of Phulbani & Khajuripada blocks with the support of NAWO Odisha. The objective was to discuss about the duty and responsibility of women PRI members, and create awareness on

different government scheme & Facilities and different acts & laws for women.

Ms. Pragyan Priyadarshini, NAWO was the resource person. The participatory activities at the training involved discussion and sharing of violence and problems women face in family, panchayat and community. It was apparent from discussions that there was lack of support and respect for women at all the three set-ups. Representatives came up with solutions such as unity among the women representatives, formation of forum of women representatives and understanding between man and woman. Apart from discussions, a film on the role & responsibility of the PRI members was screened as well. Ms. Swaha Das & Basant Patnaik from Aaina discussed about RSBY, Nirman Shramika Bima and NRLM for the knowledge of the women PRI members.

International day to eliminate violence against women

International Day to Eliminate Violence against Women was observed jointly by Aaina and NAWO on November 25, 2013 by organizing a scooter rally where youth from different colleges and institutions along with representatives from different organizations joined. The rally was flagged off by Mrs. Arti Ahuja, Commissioner cum Secretary, W & CD Dept. The one billion rising campaign also flagged off. The theme for this year was "One Billion Rise for Justice". People on bikes in black and white T-shirts with a message "U & ME together can stop violence against women." shouting for justice spread the message across public. The vibrant rally stopped at Master Canteen about 3KM from the starting point, and the participants gathered for a formal meet. Ms. Bisakha Bhanja, Mrs. Sneha Mishra, Secretary Aaina, Ms. Lalita Missal, State coordinator NAWO were the key speakers at the assembly. They all spoke about the non acceptance of violence against women and the need of change in the system and attitude to attain the same. Youth from different colleges also talked about the safety of girls on street and at all public places. The event revived the gravity to act towards justice for women.

Towards Child Rights

Community based practices/programs Children club



To address social exclusion of children and give voice to them, Aaina has established children clubs under different projects. After the initial orientation and sensitization of the members on child rights, and its violation issues, the clubs conduct their activities independently. Children within the community are increasingly sensitized towards the existing discriminations. They are learning how to counter these issues. Children in these clubs are also initiating programs such as child journalism, and taking ownership of the effort to end exclusion within their community. The children clubs are therefore the locus for both ventilating problems as well as stimulating response to these issues.

Community participation through Suggestion box

One of the innovative and democratic initiatives is the installation of Suggestion Boxes in the schools and villages. Children and adults in the village are invited to put their suggestion regarding every aspect of village life, from the functioning of school, condition of village roads to child labor issues and discriminatory practices. Every month, the suggestion box committee reviews all the suggestions and actions are decided at a village public meeting. The Suggestion boxes act as a platform for children to voice their concern and ensure participation of children in child rights governance.

Strengthening of Child Protection Committees (CPC)

CPC are formed in 30 villages of G. Udayagiri block under "midanga nari reha" project that address various issues relating to child rights and protection. A committee is represented by community leaders, school teacher, PRI members. members from children club, women SHG members. These committees are periodically sensitized to pro-actively look into instances of child rights violation and initiate remedial measures. At Ratudi village the CPC interacted to assess the quantity and quality of mid day

meals. They had a discussion with the ANM regarding child health, low blood pressure and Mamata Yojana, Drinking water problem, Inclusion of a migrated family were the other issues the CPC attended to.

Trainings and apacity building Training on exclusion mapping

To enhance the participatory community action against social exclusion in 30 villages of G. Udayagiri block a remapping of the situation was initiated. Children & adults from the villages were trained on the method, mechanism and skills to conduct exclusion mapping at their places. With the active participation of them in the whole process, the children were able to estimate and concretize the magnitude of apathy, neglect and loss happening at specific location due to visible and subtle exclusion process. This gave the children and community people definite idea on how much and where to intervene. The data also highlighted the status of child education, child labour, education of child with disability, girl child and access of different facilities and schemes.

Training on IEC material production for electronic and print media

Aaina with support of Save the Children this year trained the children on IEC material production for electronic and print media. The process encouraged the creativity and innovation among the children. 20 such workshops were organized as a result the children came up with case studies and their experiences on discriminations faced and many other social issues. They helped in the preparation of design layout and content of the quarterly child magazine "Ama Swara" and independently preparing themes of poster, leaflets etc.

Events and observations

District level child rights week

Aaina celebrated Child Rights Week at district level in Phulbani on 16th November . An awareness rally was started from District Veterinary Training Hall at 10.30 AM with placards spreading the massage of rights of children, rights of education for person with disability and the rights of participation of children at every level. The guests on this occasion stressed on the importance of education for children to meet their dreams.

They advised the children to stand up against discrimination, especially meted out to girls. They also made the children aware of different schemes and entitlement for the education of children, asked them to fully utilize the same and continue with their studies. On the spot song competition, dance competition and one act play & fancy dress competition were organized for the children of different children clubs. Winners of various competitions were given away prizes.

Disaster Management

Aaina's humanitarian response to the disaster situation post "Phailin"

The very severe cyclonic storm "Phailin" struck the Odisha coast on 12th October 2014. The state sustained massive infra-structural, property, agricultural and financial damage, though there was zero casualty due to the extensive evacuation earlier. But the situation became quite complex with incessant rain pounding the state over 15 days and large tracts of land getting flooded or water logged.

Aaina responded immediately by mobilizing its own staff from various locations to join the existing staffs in Ganjam to reach out to people with relief materials in the most affected areas. In first lot Aaina distributed flattened rice, jaggery, biscuits, candles, matchboxes and sanitary napkins in 20 villages which was totally from Aaina's own resources. The employees also contributed their 5 days salary towards the relief operation. A rapid

assessment of the situation focusing on loss sustained, immediate needs and short term recovery support was conducted. Specific attention was given to women, children and persons with disability and also to the WASH aspect. Aaina with the support from different Corporates



and International Agencies reached out to the affected people in 23 villages in 5 blocks with food materials, utensils set, floor mattresses, blankets, tarpaulins, tents, house utilities, solar lights, mosquito net, seed packets and assistive devices to the people with disabilities. WASH aspect in 70 villages in 3 blocks was addressed through the community people by renovation, revival, repair of water bodies and sources utilizing halogen, bleaching powder, gypsum after demonstrating the water testing kits. People were guided to clean the village environment and use pit or trench latrines during this time. The agencies who partnered Aaina in this endeavour are, Save the Children, ADP Hyderabad, Bharti Infratel, Harsh Foundation, Water Aid, Handicap International, Times of India along with some individual donors. Our organization was also part of the inter

agency coordination team for the Ganjam district where all the collective relief responses were reviewed by the district collector and works were distributed.

At the other end the Odisha Phailin Response Forum was formed on 8th October 2014 by 43 experienced NGOs and INGO to better manage and coordinate the GO & NGO post Phailin response. Aaina took direct charge of collecting information from different partners and circulating it through a e-newsbulletin daily. 20 such bulletin were published. Besides Aaina lead the sub-theme groups on children and disability within this forum deliberating various scenarios and developments and came out with suggestive guidelines. This helped in timely intervention for the people in the affected areas...

Aaina and OPRF

Aaina was a proactive member of OPRF, Odisha Phailin Response Forum. OPRf was the immediate response of the civil society to Phailin situation. The members

control room with collecting and disseminating information about the Phailin. The OPRF was running with a volunteer coordination cell and in continuous touch with the administration on



volunteers' mobilisation and deployment in different district. Experienced with 1999 super cyclone the OPRF members were in close contact with the people at all the districts having high alert for the Phailin. The major objective of the forum was to complement and supplement the activities of the Govt and to work in collaboration with the Govt. It was decided to mobilise and coordinate volunteers to work in the affected area. Apart from these activities Aaina contributed towards the OPRF bulletin updating on everyday basis about the field's current situation situations and actions taken. The bulletin was published daily initially and on alternate days at a later stage.

The Dasra team was specifically impressed by the menstrual hygiene Management project of aaina . Two staff members even paid a visit to Aaina to have a first hand look at the project.

Some people donate money, some their time, some materials, and some just pure love. Daan Utsav is celebrated for a week starting from Gandhi Jayanti (Oct 2-8) every year, and was started in 2009.

Breaking the barriers

Sangeeta Behera, a 14 yrs old girl with speech and hearing impairment lives with her parents in Tentuligarh village of Kandhamal. She attended school regularly up to class 5 and was interested to continue her studies. However, with the new school every thing changed. The staffs refrained her from participation in regular activities and extra-curricular activities at school. Students mocked her frequently. Faced with such behavior and attitude, she developed repulsion and resentment. As a result she discontinued her studies and was even hesitant to go anywhere else. Some time later a Children Club was formed in Tentuligarh. The children came to know about child rights, and the social exclusion processes especially of children with disability. They decided to raise their voices and act for an inclusive society. Sangeeta' was invited to join the children's club but she declined. But the children persisted and she relented. With time, the members of the club suggested Sangeeta to re-join school and assured that she will never face any kind of difficulties like before. The members of the children's club also came forward to share the situation with members of Child Protection Committee. The staff of Aaina and the children's club members discussed Sangeeta's case with the school authorities and they agreed to enroll Sangeeta in school. Now Sangeeta goes to the new school regularly. Finally she has battled disability and enjoys her life.

Durga-rides with pride

Durga, a cheerful and confident, 30 year old wheel chair bound lady was selected by Aaina to get a motorized vehicle from Rajiv Gandhi Foundation. She is a tailor by profession, and lives in Cuttuck with her mother, father, brother and sister in law. While sharing her life changing experience after one year of receiving the vehicle, she said that life has changed for the better by opening so many avenues that she had not thought of before. it took her only 1 day to learn riding the vehicle! She learnt it from a known auto driver as there was no support coming from the family members. Earlier, she had to travel in a rickshaw to buy materials from far off market, which was both time consuming and expensive. Now in her motorized vehicle she can get the materials much faster independently. The vehicle has changed her life otherwise as well. Being wheelchair bound, she was restricted to her house. Now she travels to neighboring cities for work, socialization and leisure that she had not gone for years. Puri beach is one of her favorite destinations. She is now overall more confident and independent. The attitudes of neighbors and society towards her is changing as well. Earlier, who perceived her as burden on the family now respect her for the courage and support her whenever required. Yet the male members of her family, especially her brother have not accepted her independence and never help her in taking care of the vehicle or maneuvering it through the narrow streets leading to her house. It is the neighbors instead who extend the help. No qualms, Durga is strong and enjoying every aspect of her life.

Celebrating Aaina's 15 years

Aaina completed 15 years of its inception on January 15, 2014. To celebrate the same, a General Body meet was organised by Aaina on January 29 at Barkul. All the Aaina staff, ex staff and EC members were invited. It was a memorable gathering of 94

persons where ex employees, current employees and Founder members shared their experiences working at Aaina. Children of few of the employees had joined along adding to the liveliness. Ms. Sneha Mishra, Secretary Aaina spoke about 15 years of journey of Aaina, different achievements, struggles and plans for future. Employees who



had worked or have been working for more than 10 years were awarded with a trophy and a cash prize of Rs.10.000 as a token of appreciation. All the present people received a wrist watch with an Aaina logo. Two hours of boat ride around Chilika lake afterwards was equally enjoyable and refreshing. The General Body meet was a wonderful reunion of past and present staff filled with emotions and excitement reviving their association with Aaina that bonds them together.





