The news of passing away of our ex-president Dr. Meera Banik came as a shock and disbelief especially after her great presence and lively countenance in the Executive Committee meeting held just two days before. We are left speechless. The emptiness still continues! It's a personal loss to me as I lost a great teacher, guide, friend and motherly figure!! I join with my colleagues and esteemed members in praying God to rest the great soul in Peace!!

Coming back to the current activities, the significant association with Sense International India to extend the services for children with deaf blindness and



multi sensory impairment took off with great enthusiasm! This gave us an opportunity to learn of many uncovered area and a situation where challenges were met with challenging actions for the challenged in the field of disability! Heartfelt thanks to Sense International India for giving this opportunity to learn about MSI and serving the much marginalized sector within disability.

Taking up the issues of women workers in informal sector is the other work in the area of women's empowerment carried on in the last year. Thanks to SEWA & ILO for the trust bestowed on us for the community intervention through the impact assessment project. It is a great experience getting into the issues of women workers in informal sector with a focus on domestic workers. Nalini Nayak from SEWA needs a special mention for her continuous and relentless input to the project and giving it a shape.

The regular project of Inclusive WASH and CBR along with "We Care" took a momentum in the current year with additional component and also in terms of professional intervention. While the Inclusive WASH project supported by Water Aid India provided an opportunity to promote inclusion in WASH sector the other two projects that focuses more on disability also included WASH as an intervention agenda.

The project supported by DFID- PACS came to an end in Kandhamal. Thanks to Mr Ranjan Panda and team for taking up the systematic evaluation of the project and coming up with the achievements and challenges. We reached out to 60500 families creating awareness on Govt schemes and benefits. 12420 families were directly linked with govt schemes through MGNREGA, IAY, NRLM etc. Nearly 720 out of school and non initiators children were enrolled in Schools including 217 children with disabilities. 117 children including 14 children with disabilities took part in SMC.

Kallola-2 with the new component of Junior Kallola where children are to make films was declared in March 2016. We look forward to its new incarnation.

I take this opportunity to thank all the esteemed members, colleagues, support agencies, donors and friends those have been associated with us directly or indirectly to make things happen. I look forward to all of your support in coming years...

ABOUT AAINA

"Realization being the Guiding Mantra, Creativity and Inclusion the Spirit" we at Aaina are committed to promote inclusion in its true sense wherever and whenever possible. The action or state of including or of being included within a group or structure as a whole means Inclusion. Inclusion means change!! We believe both inclusion and change are inevitable. Whether we choose to grow with and from these changes is a choice. This also means including the people those are historically marginalised and accepted as they are. Thus the larger sector create space to their need than asking them to change to fit into the system or society. Aaina has been trying to promote inclusion of people and children with disability in the development arena through its very focused projects. They remain vital stakeholders of all the projects and their participation is interwoven in working strategy of Aaina.

'Amo Vidyalaya' which was the first ever community level program of Aaina came into existence in the year 1998 at Baranga, Cuttack, It acts as a platform for children with disability to be a visible part of the society, learn and grow together in a non residential model, catering services to the children with disability for mainstreaming. Along with education vocational training is also another part of the curriculum for the older one to become independent in the near future.

The inclusive children clubs approach made the process of Inclusion much easier in villages and Schools and remains another strong example of social inclusion of children and children with disability. We believe that, "Children those study together learn to stay together in future". The aim of the children's clubs is to give a voice to excluded children and promote their rights. Today there are children's clubs in every village of Aaina's intervention where children participate and discuss social issues affecting them and society in general. To support their voices Child Protection Committees are formed and developed where children not only raise issue but are very much part of the committees and share their issues with service providers. This platform is available in the district of Kandhamal, Ganjam, Boudh and Dhenkanal of Odisha and now regular talks is happening to include them in ICPS model in terms of sustainability.

Facilitating people with disability through economic and social empowerment have made them realize their capabilities and get mainstreamed in society. Through Ananya project 151 SHGs of persons with disability got training under NABARD and were linked to various lead banks to be fully functional and some of them are running their IGP activities individually and also in groups. It not only changes the mindset of the individual but also the community as a whole towards persons with disabilities.

Aaina continues programs at various levels for the people with disability to supplement the cause of Inclusion. Regular orientation programs are organized for both government officials and the various stake holders including PRI representatives, school-teachers, members of community etc. Besides attempts are also made to ensure that the various facilities given to this special groups reaches them such as aids and appliances, scholarships for children, IAY, disability certificate, bus and train pass. Sensitization and bringing visibility to the potential of the PWDs made the Inclusion process easier and smooth.

PWDs also have a right to work and it is covered under MGNREGA. Aaina took an initiative in Kandhamal and Boudh district with the support of DFID-PACS to ensure the participation of PWD in MGNREGA and have been promoting and tracking the involvement of nearly 612 PWDs working under the scheme. The inclusive 'Shramika Sanghas' were instrumental in understanding and demanding the work for PWDs as per their need. Aaina thus carries out the endeavor of inclusion as an interwoven part of its working strategy.

With the support of wateraid, India Aaina promotes the health and wellbeing of adolescent girls and women in the district of Ganjam with a special focus on MHM-menstrual hygiene management and also advocating for the WASH issues.

Apart from that Aaina also facilitating the process of SBM-Swachha Bharat Mission in 7 G.Ps of Ganjam district by creating awareness in the community, demand generation and behavior change. Also to look at the supply part Aaina with the help of block administration creating human resource in terms of CLTS motivator and masons and to keep an eye on IHHL construction by the Kishorisathi's on quality and accessibility aspect.

Working for the children with deaf blindness and Multi Sensory Impairment through education, therapeutic service and community awareness is a new challenge taken up in collaboration with Sense International India. The trained staff of Aaina keeping constantly working with both the parents and teachers in the district of Ganjam and Khurda. State learning centre is operational in the head office premise catering to the education, therapy and information services for the people with deaf blindness and MSI from anywhere the state.

Aaina added to its success by joining hands with UNICEF in organizing Kallola a short documentary competition on child rights. This year theme was ending violence against children. Twenty seven short documentary movies were received from students, upcoming film makers and professionals. The film broadened the understanding of viewers on violence against children. The special feature of the program was viewership by children and jury and separate award was presented as children's choice. The initiative gave an opportunity to understand violence from children's perspective and bring forward their opinion on violence against children. The event was perceived as a catalyst to bring long term social change.

Aaina also promotes and establish WE CARE FILM FEST which is a travelling film festival with the aim of raising awareness about disability through the medium of films. The event develops integration in society by spreading the massage of ability. Aaina in association with Brotherhood organized We Care Film fest-V in the auditorium of Institute of Engineers where short film competition was held on the issue of disability and promoting ability. Award winning documentaries were screened to create awareness about the ability of Persons with disability among the representative from media houses, celebrities, duty bearers from the government, school students and college students. This year 35 entries of short films were received for the competition and more than 1000 viewers along with the guests attended the program.

Remembering Dr. Meera Banik



Dr. Meera Banik, the eldest EC member and Ex president of Aaina passed away on January 12, 2016. She was closely associated with Aaina from the beginning and led the organization as a President from 2001 to 2011. She keenly followed the planning and designing of projects and annual budgets of Aaina and gave her specific insight to it. She was very regular in her presence in EC meetings where she always had views and suggestions to share.

Besides being a learned educationist she had an innate ability to connect with the staff. Each staff could find affection and love in her. She thought of welfare of staff and spontaneously was ready to guide them whenever she could. Many of the staff could relate with her as their: "guardian". She had a soft corner for children and was keen on working for the betterment of underprivileged children. She regularly visited Amo Vidyalya and discussed with children about their passions and activities. She hoped for a more structured support from government towards the betterment of Amo Vidyalaya.

She step down as President the moment personal pre occupation interfered with her commitment to the position. Still she remained an active EC member and

was present in almost all the major events organized by Aaina. With passing years, her enthusiasm and participation in different projects never diminished. Three days before her unfortunate demise, Dr. Meera actively participated in Aaina's EC member meeting on Jan 9th, 2016. She was present for Workshop on Trafficking of Women with Disability organized by Aaina on December 7th and 8th 2015 as well. The emptiness devoid of her dedication, affection and activism shall always be felt by Aaina.



Towards Inclusion

Aaina Embraces Inclusion through Sign Language at Raahgiri

Since January 2016 each Sunday morning a stretch at Janpath gives way to "Raahgiri" that encompasses diverse activities from cycle rallies to yoga sessions to music orchestra to story telling for children. Visitors from all ages and background visit enthusiastically to participate and browse through the activities.

Aaina embraced the opportunity to promote inclusion and teach basic sign language to visitors



at Raahgiri and widening up the scope of sign language. Youth and children remain special visitors. Children are extremely enthusiastic to learn this new language moving their little hands ambitiously. Visitors standing in front of the Sign Chart and trying to practice alphabets on their own has become a typical scene. Visitors are enquiring on learning it further. Children want it to be a part of their school activity as well. Seeing the interest, Aaina plans to promote teaching sign language in a formal manner by partnering with professionals.

Reaching the Unreached: home based trainings to improve functional capabilities and independence of children with deafblindness

Reaching the Unreached project of Aaina with support of Sense International India recognizes deafblind as a separate category needing provision accordingly. Presence of both hearing and visual impairment tends to put children in complete isolation as they cannot communicate, get

information from environment and see emotions. Their movement is also restricted leaving them confined to household bounderies. Despite being present they remain invisible in society. Reaching the Unreached project of Aaina aims to promote inclusion of children with deafblindness and children with multiple sensory impairment. The process begins from the very basic level of first identifying the potential of children and creating



confidence in children and their parents and community about the potential of the children. Currently the project running in Khurda and Ganjam districts. Through home visits, the staff is currently involved in providing training to the child and family members of the children to improve upon grooming, mobility and communication with these children. Efforts are being made to bring change in the mindset of percieving deaf blind children from being "totally dependent" to being functional and capable. education mainstreaming is yet another effort by collaborating with SSA-OPEPA and explicit programmed planning for the children.

Amo Vidyalaya

Amovidiyalaya is an integral school at Barang preparing children with disability for mainstream education and providing vocational training to children and people with disability. Being a day care

school in the center of the community allows children and people with disability to participate in the activities and remain connected to the community as well. The school works as a platform and as a stepping stone for children with disability and people with disability to become a part of the mainstream society. Assessment of each child is done and individual goals are set accordingly.

They were facilitated to sell different products in market made by them. This year children made file, folder, candles, hand bag, wall hanging and change purse. The products were sold at Bali Yatra. The proceeds from the sale was used towards buying more raw material and for the development of the children. Further awareness was provided on how the group can take help from



government. Children are facilitated in getting disability certificate and disability pension. Other activities that keep children motivated and involved in the community include their participation in We Care Film Fest, Independence Day, Republic Day, Saraswati puja and Ganesh puja.

Towards Inclusion Project

After 4 long years, the Toward Inclusion project of Aaina supported by PACS came to closure in February 2016. The project operated in two of the remotest districts, Kandhamal and Boudh of Odiha and covered 350 villages. It facilitated the inclusion of the children and persons with disabilityies and other excluded groups in education and livelihood. The project had a clear mandate to work with the excluded groups and bring them to forefront with



rights awareness and developing capacity of demanding the rights. 350 Sramika Sanghas & 350 Children Clubs were formed during the project period. Through groups, there is a remarkable increase in the number of persons availing job under MGNREGA. There is more regular payment of wages to the workers and better access to govt. schemes and facilities. 65 DPOs federated into district level and linked to Mission Shakti program

Through the involvement of CPC, Children's Clubs, SMC members 718 children got admitted into the general schools, including 217 CwDs. A total of 112 children are members of the SMC out of whom 14 are CwDs. They are addressing the issues of the children in different forums like-CWC, SMC meetings and CPC meetings. We are looking forward for productive partnerships to carry the project forward.

We Care Film Fest V

"We are not here to change them, they are here to change us" shared Ms. Gungun (Odiya Cine Artist) present as a guest of honor at We Care Film Fest V. Probably her statement was true. There has been change in the mindset of people towards disability after experiencing We Care film Fest organized by Aaina that showcases ability and inclusion in disability through the medium of national and international short films on disability. The 5th successful year of We Care film Fest also coincided



with World Cerebral Palsy Day and a rally was organized on the occasion where children with disability and cerebral palsy, NGO staff, Aaina EC members and staff marched creating awareness about the day and facts of Cerebral Palsy. Poster Competition was a special features this year. Panel discussion on "Mainstream Cinema & Portrayal of Disability", "Disability - A CSR Issue - Prospect & Challenges" and "Smart City Bhubaneswar & PWD" forced present authorities and

audience to view disability in a broader sense and account for the necessary steps to be taken for a more inclusive approach. Finally the short documentaries from local film making professional and amateurs depicting disability aspects where screened. The festival attracted students, children with disability, social activists, government officials, non-government officials and media

Satyabhama- A Community Based Rehabilitation Approach

Project Satyabhama a Community Based Rehabilitation project for People with Disabilities, in 2 blocks of Dhenkanal, Kamakhyanagar and Kanknahad aims to make children, people with disability and women aware about different government schemes and benefits. Through capacity building trainings, the staff makes them aware of their participatory rights in education and health. For organized action, project facilitates formation and strengthening of



different community groups and their linkages with related government department.

This years' highlights include: A survey to know about the children who have been deprived of their right to education and making them aware of their rights through RTE; Speech therapy provision at Resource Center for enabling participation of children with speech impairment. DPOs have been formed, where each member saves an amount to run a common small business. A federation to discuss issues on a single platform has formed. Each member of the federation is involved in development of their block.

- Children want sign language to be a part of their school activity
- 17 deafblind children identified and have Individual Education Plan
- Parents and community now more aware of the children's capabilities
- Resource Center providing group services to children
- 35 children with disability provided academic education with 1 new admission
- 8 children applied for Banisher scholarship.
- 30 girls and boys given vocational training and know how on marketing the different products.
- SHG formed in three more villages
- Inclusive education in 282 Primary schools and 104 Secondary schools
- 227 excluded children enrolled into mainstream education
- 350 numbers of children groups were formed for governance in 350 schools of Boudh & Kandhamal district

- 3983 women demanded and received job through MGNREGA.
- 442 PWDs demanded and received job through MGNREGA
- 65 DPOs federated into district level and linked to Mission Shakti program
- 702 participated in We Care film Fest
- 18 posters and 19 film entries received on disability
- Inclusion of disability in films to increase awareness among common masses was encouraged
- Training on RTE organized for children with disability
- Training on speech therapy organized
- 30 new DPOs and a common federation formed
- CFL bulb fitting training provided and 3 are professionally working.

Women's Empowerment and Equality

Work in Freedom

Women working as domestic workers are deprived of their rights as labor workers and remain

unorganized labor sector facing illegitimate behavior and circumstances. Migrating women especially remain vulnerable to trafficking in the name of domestic work; Lack of proper structured information to potential migrants leaves them even more vulnerable. The scenario is very much prevalent in Ganjam district of Odisha though it needs to come to the surface in terms of visibility. The Work in Freedom project in partnership with ILO and SEWA operating in Bhanjanagar and



Surada Block, aims for Empowering Potential Women Migrants (for domestic work), Adolescent Girls and their Families, and Community at large to enable safe and informed migration, and to facilitate linkages to government and non-government services and schemes.

Capacity of the staff has been developed to understand complicacies related to migration and how to develop institutional mechanisms to facilitate safe and decent migration with active support of local level administration.

Besides creating awareness on safe migration women are made aware of livelihood options and government schemes such as NRLM and MGNREGA for their secure future.

For an organized action and rights of women there has been an establishment of the SEWA union in Odisha that will be the organization of the workers themselves to further the pursuance of their rights and social security. The program also encourages greater female participation in workers' organizations. After Participatory Rural Appraisal exercise and through door to door outreach list of the potential migrant workers were identified.

Pre departure trainings are organized to sensitize and empower the identified potential migrant workers to make informed decisions regarding migration and how to migrate safely for domestic work in and outside the state.

Convention on Trafficking of Women with Disabilities

Gender based Trafficking is one of the worse forms of violence against women. UN Office on Drugs and Crime (UNODC) define human trafficking as the acquisition of people by improper means such as force, fraud or deception, with the aim of exploiting them. Social exclusion, low self esteem, weak bargaining power with lesser access to education, employment and attitudinal barriers of society leave Women with Disability vulnerable to fall into the trap of trafficking. Yet, due to the

invisibility of the issue, very less evidence is available.

A Convention on Trafficking of Women with disabilities and its Underpinning Causes was organized by Aaina on 7th and 8th December supported by U.S. Consulate Hyderabad. Mr. Gabriel Hons-Olivier, Public Affairs Officer U.S Consulate (Hyderabad), Dr. Minati Behera State Commissioner for Persons with Disabilities, Ms. Bishakha Bhanja, Convener Jajnaseni, Ms. Lalita



Missal, President aaina, Dr. Amrita Patel, Project Director, State Resource Center of Women (WCD Dept), Ms. Sujata Jena, Advocate Odisha High Court, and Mr. Manoj Tripathy, Program Manager (ICPS) were amongst the esteemed guests.

The convention was a platform for service providers, officers from legal, government and non government departments to exchange information on this particular sensitive issue.

The conventions and data drew attention towards much needed coordination among governmental, non government organizations and legal department to minimize trafficking of women with disability. Community level intervention came out as vital to prevent trafficking and also for rehabilitation of trafficked survivors by accepting them in society respectfully. Besides, well equipped short stay homes for women with disability were needed.

Education of girls and their awareness on trafficking issues of women and children were considered vital steps to prevent trafficking of girls and women with disability. Also a need for stronger prosecution mechanism came at forefront.

Child Rights

Kallola Film Festival

Kallola a short film contest on child rights held by Aaina with support of Unicef entered the 2nd year. This year's theme is Discrimination against Girls. This year it was thought to see the perspective of children on the issue through films made by them. So, children from 5 schools were picked up for a thorough training on the technicalities of film making and final production.



The workshop is organized for children where professionals guided children on the process of film making. The children have been most enthusiastic to take up the challenge. They are sharing their experiences, exposure visits and observing different aspects including discrimination, writing and modification of script. further to come is taking shots and editing, and identifying locations for the shooting.

We look forward to Artist Ready, Camera Rolling, Action! - School Children set to make short film.

Joy of Giving

An Apple a Day, Made it Way! On the occasion of Daan Utsav, Aaina organized a "Gift an Apple campaign" where buyers could donate apples to become a part of the mid day meal for children in government schools. The apples add taste, nutrition and simply joy in the diet of children who may not be able to afford it otherwise. Udyan Fresh and Reliance Fresh, leading grocery store chains of Odisha partnered with Aaina in this campaign by



being the host grocery stores. As such people visiting any of the branches of these stores in Odisha during Daan Utsav (Oct 2- Oct 8) could donate apples towards the cause. These apples were distributed among 792 children in different primary government schools. Children were excited and relished the tasty and nutritious addition to their mundane meal which was reflected in the twinkle of their eyes, their smiles and laughter upon getting the apples. School authorities appreciated the initiative as well. Aaina hopes to take this campaign further by trying to make it a year round activity for few schools through coordination with participating stores.

Wishes of 58 children with disability met through Wish Tree as Aaina partners with Bharti Infratel during Daan Utsav:

Like every year, Aaina put up a wish tree during Daan Utsav 2015. The tree prepared contained specific wishes of children with disability under Aaina's project Reaching the

Unreached and Satyabhama. Bharti Infratel, a leading telecom infrastructure provider company most willingly agreed to partner in this project and the Wish Tree was placed at their premises in Bhubaneswar from October 5 to October 13. A total of 58 wishes were met amounting to Rs. 19400/-. The wishes fulfilled ranged from school bags, Tiffin box to nutritional needs, winter clothes and money



towards physiotherapy for children with disability. the wishes were fulfilled at the doorsteps of the children's house. People in neighborhood and community were equally excited to see the support provided by Aaina.

- 15 children from 5 different schools(DAV Public School, Capital High School, Sri Aurobindo Institute of Integral Education, Govt. Girls High School Unit- IX and St. Xavier High School) participating in the film making process on discrimination against girl child Discrimination in terms of education, health and care, child birth and profession has been amongst the favorite topics.
- 160 KG apples collected and distributed adding taste and nutrition in the mid day meals of 792 children
- 58 wishes were met ranging from school bags, Tiffin box to nutritional needs, winter clothes and money towards physiotherapy for children with disability amounting to Rs. 19400/-.

Networking and Partnerships

Project of creating Open Defecation Free Society in partnership with Wateraid in full Swing

Realizing the importance of sanitation and hygiene Aaina collaborated with District Water Sanitation Mission to create awareness on WASH. The MHM Inclusive WASH project in partnership with Wateraid expanded to another two blocks of Chhatrapur & Rangeilunda of Ganjam District

One of the primary focus is to create 5 Open Defecation Free communities in 5 blocks of Ganjam. It is noted that construction of toilets is not



enough, but availability of water in the toilets, their accessibility and above all change in the mindset of people who are used to defecate in open is vital for the usage of toilets.

Aaina is particularly responsible for creating demand among community for toilets through behavior change, development of IEC material, Community Led Total Sanitation training and Mason training. Capacity building trainings of PRI members on WASH organized by Aaina made members realize their vital role to make a GP Open Defecation Free (ODF). Believing youth as strong change agents Aaina organized a Community Led Total Sanitation program where 40 adolescent boys and girls from operational blocks participated. Villagers from Patapur gave a demand letter for their toilet construction to the BDO as they realized the importance of toilet and its benefit. There are 300 toilets constructed in 6 villages of Padmapur GP under SBM covering 1438 house hold.

- 25050 house hold, 240 schools and 211 Anganwadi centers covered in the WASH project.
- Observation of District level Global Hand Wash Day and Toilet Day
- In collaboration with UNICEF & DWSM, Ganjam Aaina organized 2 CLTS training program training 90 participants.
- 80 Masons were trained on the technical know how of the specific toilet construction under SBM

Deafblindness is minority within the minority and hardly acknowledged within the disability sector. By the nature of combination of impairment of vision as well as hearing, children with deafblindness are forced to live in a cocoon of isolation because many of us do not know how to communicate with them. SEWA commenced working with Aaina as a member of the NAWO platform in 2014. This was a part of a programme on safe migration of women and girls and organizing domestic workers in collaboration with the ILO. SEWA interacted closely with the field organisers of Aaina in Khandmal district who was extremely committed and very resourceful. In mid 2015, SEWA undertook a more intensive program with Aaina in Ganjam district on the same subject. This got the entire team of Aaina involved. The subject was new but the team was open to learn. Aaina's extensive contacts, network and credibility in the area facilitated the



work. But what was a new and big learning from SEWA was the fact that Aaina focused on the disabled people and as a policy engaged 18% disabled people in the work team of any program. I was also welcomed and at home with other disabled people in the Bhubaneshwar office of Aaina. This inspired me to try to develop this awareness in SEWA as well.

Aaina also courageously took the initiative to organize a State Conference on Violence against Women with Disabilities: Trafficking of Women with Disabilities and its Underpinning Causes. The first of its kind in India I am sure. It was interesting to hear from the ILO resource person that there were also several ILO references to disability of the Workforce. So this inter organization collaboration brought mutual learning to all the partners and was extremely fruitful.

The other impressive feature is the importance that Aaina gives to work in the cultural field, particularly cinema. It organizes a festival every year. One does not find this normally in an NGO that generally engages in developmental activity and women's issues. Hence it was also in the work on domestic workers that they suggested that we budget for a cinema clip on domestic workers to achieve a larger outreach on this sector. Great idea and it worked.

On the whole therefore the collaboration has been enriching. Aaina has not shied away from taking action to its logical end - building of the SEWA trade union among workers in the informal sector and intercepting the trafficking chain by following up cases with the crime branch and protecting the victims.

I wish Aaina success in its future work and am hopeful that SEWA union will also sprout deep roots through the NAWO network in Orissa.

Exposure Visit

Understanding the best practices on SBM

Mr. Dillip Kumar Biswal, Ms. Jyoshna Sahoo, Ms. Rajalaxmi Mohanty, Ms. Sanghamitra Nayak, Ms. Sujata Nayak, Ms. Lipina Muduli, Mr. Ashok Dash and Mr. Balaram Sahu from Aaina undertook a 3days visit to Gramjyoti, Deogarh, Jharkhand with the objective to understand the best practices on SBM and also the active involvement of PRI members.

During the observation and discussion it came out that there is a proper coordination between the department, development organization and the PRI members in SBM and by this effort 3 blocks are already declared as ODF in the operational area of Gramjyoti.

We have interacted with the PRI members and other duty bearers regarding their involvement to make a success in SBM.

We have gone through the IEC materials, public awareness program through street play which is an important media to understand SBM and also the sanitation park which is a important one to disseminate various models, technical knowledge and equipments for construction of IHHL in the state. We have interacted with the staffs engaged in WASH program about their experience in this project. We also discussed regarding MHM which we have implemented successfully and handed over some IEC materials to them to include in their program.

U.S. Exchange

I am privileged to get an opportunity from the USA state department to take part in the Indo-Pak exchange program on GBV (gender based violence) where a team of 4 people from each country got a chance to visit different states of USA to know about the work related to GBV.

The visit was planned in a way so that we get exposure on management of gender based violence at central, state, district level and also meet the victims and listen to their experiences. Really amazed to see different civil society organizations addressing the issue of sexual and domestic violence, support mechanism they get from the state parties, and different hotlines present

statewide and especially impressed by the working strategy of "No More Tears" organization in Miami where all the services were provided under one roof and the passion and dedication that the staff was embedded with.

While on one hand I liked the systematic and well coordinated approach of the country to handle the issue of gender based violence, also felt lack of "Community approach" and more of "Institutional" remedies to resolve the issue. Besides, learning about the U.S. culture, through exchange program, we i.e. the visitors from India and Pakistan could learn both from each other's culture, attitude, laws and policies, bottle necks at implementation level etc.

After the exchange program, am geared to be more systematic, more punctual, and confident in taking up new challenges. Moreover, the visit served as a good platform to network with different sets of people in terms of networking, fund raising and knowledge sharing.

My sincere thanks to US Consulate, Hydrabad office and the team for giving me this opportunity and my organization Aaina for believing in me.


